**ELIGIBILITY:**

- AC Tune up rebates are available to Residential and Business customers with Central Air Conditioning units of 5 tons or less.
- Tune up must be performed by a professional service technician within the calendar year and include the 12 point inspection completed (see form on right).

**HOW TO APPLY:**

1. To qualify for the \$25 bill credit, the applicant must meet all of the eligibility conditions (see above) complete the application (see form on right)
2. Application must be received within 6 months of purchase date or before the end of the calendar year, whichever occurs first.
3. Attach the sales receipt (or a copy of the receipt) or paid invoice from a professional heating and cooling inspection and tune-up service.
4. The receipt or inspection documentation must indicate the date of service, dealer name, and an itemized list of service check- points, and any repair recommendations.
